

For most individuals, the most difficult part of purchasing a home, especially for first time home buyers, is the ability to save the required down payment. Adapt Mortgage allows for individuals to borrow the necessary funds to use as their down payment, commonly referred to as Flex Down or Borrowed Down Payment.
